We Do Not Sell Your Personal Information

You possess the right to be informed if your personal information is being sold. Under Malaysian privacy legislation, a "sale" of your personal information is defined as the transfer of your data to a third party in exchange for monetary gain or other valuable benefits, outside the bounds of what is considered a "business purpose." It's important to clarify that such a "sale" does not encompass the sharing of your personal information when initiated by you or when the law otherwise permits such sharing. Wild Geese Group Sdn Bhd does not sell your personal data.

Control

You hold the right to execute the following actions via written request:

Inquire About Data Retention: Gain knowledge about the specific pieces of your personal information that Wild Geese Group Sdn Bhd has collected and stored over the past 12 months.

Rectify Inaccurate Information: Request corrections to any inaccurate personal information that Wild Geese Group Sdn Bhd may have retained about you.

Obtain a Copy of Your Data: Secure a written copy of the personal information about you that is in Wild Geese Group Sdn Bhd's possession.

Erase Your Personal Information: Ask for the deletion of your personal information stored by Wild Geese Group Sdn Bhd.

To exercise any of these rights, you must submit a written request to us. Upon receipt of a valid request, we will carry out the action in compliance with applicable laws and regulations.

Your Rights to Limit Data Use and Disclosure with Wild Geese Group Sdn Bhd

In accordance with applicable data privacy laws, you possess the right to restrict the utilization or sharing of your sensitive information for the following categories of activities:

Fulfill Service Expectations: Limit data use to the execution of services or provision of goods that you reasonably anticipate.

Security and Integrity: Constrain data usage to activities that legitimately and proportionally secure and maintain the integrity of our services, systems, and data. This also includes action against deceptive, fraudulent, or illegal activities and protection of individuals' physical well-being.

Transient Use: Allow short-term, transient usage of data (such as for non-personalized advertising), provided that the information is not shared with a third party, not utilized for profiling, and doesn't alter your experience beyond the current interaction with Wild Geese Group Sdn Bhd.

Third-Party Services: Limit the data usage to perform services on behalf of Wild Geese Group Sdn Bhd, such as account maintenance, customer service, transaction processing, customer verification, payment processing, providing analytics, data storage, and other similar activities.

Quality and Enhancement: Restrict data use to activities designed to verify or improve the quality, safety, or functionality of services or devices owned or controlled by Wild Geese Group Sdn Bhd.

Non-Character Inference: Limit the collection or processing of sensitive data when it is not used for inferring personal characteristics about you.
